

### TO ALL NATIONAL FEDERATIONS

As it was presented during the WKF Congress in Budapest 2023, and for the conclusion of the WKF Guardian Girls Global Karate Project during 2023, the WKF will organize a training course for women self-defense instructors, to obtain the WKF Guardian Girls Karate diploma.

The objective of this training course is to <u>create a network of WKF Guardian Girls Karate Instructors</u>, who train women around the world to promote gender equality and the women empowerment to defend themselves from all forms of Gender-Based Violence (GBV) through Karate training.

The course will be organized in Madrid, Spain, WKF Headquarters, from December 6th to 8th 2023, in coordination with the Royal Spanish Karate Federation (RFEK).

Upon completion of the course, a WKF Guardian Girls Karate Instructor diploma will be granted, that will give them the opportunity of developing Guardian Girls Karate activities worldwide.

These instructors will be able to run two different activities in coordination with the National Federations member of the WKF:

- Train other National Federation instructors from their country.
- Develop mid to long-term women self-defense seminars in their countries.

### **SELECTION CRITERIA**

The course will be developed for a maximum of 15 applicants.

The registration will be done by the National Federation, with the Application Form in attached (ANNEX I) and the Waiver of Liability (ANNEX II).

The selection criteria of the instructors are:

- Woman over 18 years old
- 2nd Dan of karate
- Elementary basic studies
- National Federation license
- Experience in women self-defense courses or training

The WKF will cover the accommodation of these candidates (Check in: October 6<sup>th</sup>, Check out: October 9<sup>th</sup>) in double room and with full board.

The National Federation must cover all round-trip travel expenses from the country of origin to Madrid, Spain.

### **REGISTRATION PROCESS**

Those National Federations that are interested in register a candidate must send an official letter to <u>wkf@wkf.net</u>, with the Application Form (ANNEX I) filled with the information of the candidate and the Waiver of Liability (ANNEX II) filled and signed by the candidate.

<u>The application must be sent before November 23<sup>rd</sup>, 2023</u>, and the registration will be carried out in strict order of application, for those applications received timely in compliance with the above criteria.
